Richard McKenzie from the Highways & Transport department at NCC replied with the following statement;

'I will need to confirm on site but from an initial look it appears that bend warning signs may be appropriate, particularly for northbound traffic which can't see the bend because of the hill. I'll look into it further and add the signs to the programme if appropriate. Signs to warn of horses, pedestrians and cyclists are not permitted where they are part of the traffic flow. Motorists are expected to know that they could come across any of those at any time virtually anywhere on the network, so we cannot provide these.

They are only permitted where horses frequently join or cross a road, or where a signed cycle route joins a road.'
